### Julie Reams, Director of Finance:

Julie is waiting on more information to continue working on the working budget. What we do know right now is the state is giving us a \$442 per pupil increase. This list is a few of the other things that we know of:

- Free breakfasts and lunches will continue
- At risk funding saw an increase of 25%
- Eliminated 147a(1) funding
- Retained transportation funding
- Eliminated 27K tuition reimbursement
- Retained Benchmark Assessment Grant
- Retained Safety and Mental Health Grant
