The land swap with the City of Fremont was scheduled to be finalized last week. Unfortunately, our attorney found several things the City needs to correct in the contract before finalization.

We had a resignation of a middle school math teacher, and the position is posted.

#### **Board Committee Reports**

Finance/Personnel – Met tonight. Pete gave the report. Everything is looking pretty good. We are currently waiting on Safety and Mental Health money to come in. We have two TA's in the budget for the ESSER3 monies, but we only have one currently. We did receive the Title funds allotment which was approximately \$100,000 more than anticipated. Our At Risk funds are also up about \$600,000. We used some money to purchase a truck for the maintenance department and hired another full-time maintenance guy.

Kim gave the Personnel report. We have a math middle school teaching position open and the Tech Director position. We currently have seven teachers expecting this year. Bing's replacement starts February 1.
