Regular Board Meeting November 14, 2022 7:00 p.m.

The Regular Board meeting of the Fremont Board of Education was called to order by President, Matt Hendrie, at 6:57 p.m.

He explained that due to privacy issues, the Board is unable to discuss specific students and disciplinary actions taken against them.

Recognitions/Presentations

Addie Shields and Josh Patterson spoke as the latest interns in the Packer Land Lab
program. Both students spoke highly of their experience working with Star of the West
Milling in growing black beans this past growing season. Addie and Josh discussed
many of the opportunities the internship gave them including job shadowing; visiting
the Star of the West Mill in Reese, MI; visiting the MSU Saginaw Valley extension office;
participation in the Gerber pea harvest; visiting American apple and Asparagus. They
reported harvesting over 106K pounds of beans.

• Mr. Wes Zerlaut, Middle School Principal, spoke about happenings at FMS. He reported great success with the recent FMS Family Night. Approximately 33% of all students were represented by a parent/guardian. Multiple community partners also participated. Both staff and parents were pleased with the event. Mr. Zerlaut reported the fall athletics season was very successful and made special note of the undefeated football team. FMS Cares has chosen the Newaygo County Compassion Home as this year's beneficiary. Finally, Mr. Zerlaut mentioned the work of Mr. Scott Breuker, FMS Technology Teacher.
