- D. Clarification of Federal Law on Bathrooms Jen read a statement on behalf of the Board. She then went on to explain the Title IX Federal Law and transgender use of bathrooms of their sexual orientation. Kim explained that she spoke with Matt regarding making all individual stalls. Michael asked about having no doors on the bathroom and looking into that situation. Jen expressed that bathroom monitors are a good idea, and that at the high school we already have staff in and out. Steve asked regarding having a boys, girls and unisex bathroom is there room size wise to make a third bathroom? That would be a question for Ryan regarding OSHA and code. Justin asked about single use stalls (like lockers) and the use of cameras at the door of the bathroom. If a student is not feeling safe using the bathroom, Justin would like to give these students some sort of leniency for tardies for the next month and a half. Brad will follow up with Wes and Carrie regarding the middle school bathrooms and use for individual students. Scott was questioned regarding the mental health program now available at the high school.
