#### **Leadership Reports**

#### Ken Haggart, Superintendent

- Ken advised that the high school SAT had an average score of 1047 which is the highest ever.
- K-12 Technology teachers With retirements, we are looking at a K-12 systemic program for our children.
- High school Assistant Principal position will be posted in January.
- In Person vs. Virtual/Concerns of Remote we all agree that in-person learning is the way to go. We were told in August that if we passed the 5% positivity rate we needed to take it very seriously. If we got to 10% we needed to seriously consider closing according to the Health Department. We have not been below that for the past week. Other districts in Newaygo County are struggling with staying open due to staffing problems with quarantining. There was discussion regarding the fact that none of our teaching staff has been positive, and that our students are doing what they need to do.
- School Equity Caucus has the primary goal to ensure equity in funding for districts. Those schools with a greater percentage of free and reduced lunch should receive more funding than those that do not. We hopefully will see some movement in the State legislature to obtain some of that equitable funding.

# **Bing Hanson, Director of Finance**

- Bing advised that most of her time appears to be being spent on the hazard pay grant. Lloyd got the information on our website with very little notice. The employees have to return their applications by December 4 at which time the administrators will review them. There is an appeals process if employees feel they should receive the pay and have not been approved for it.
- We did not get the Cares Competitive Grant this will lessen the relief funds.
- Bing will send the October financial report to the Board tomorrow.
- Auditors will be at the November 23, 2020 Board meeting.
