• Athletics – Currently winter sports are on hold. There are two college signings scheduled in the new two weeks. The coaches are doing a good job following the safety protocols with temperature checks, health screenings, etc. At this time, Monday, February 22, is the starting date for winter contact sports. There are emotional concerns with the athletes and the unknown. College recruiting is being affected and loss of scholarships. With the loss of feeder programs last summer, our varsity coaches need to be involved. It is becoming a case of the "haves" versus the "have nots" – those that have the academic means are travelling out of state to compete.

Matt asked if they will have to wear masks to complete since there are no outbreaks where they are playing in other states with no masks. At this time, masks are required. The MHSAA does meet regularly with other states organizations.

Jen asked how long will the winter season be. The last known was a seven-week season before this last pause. MHSAA is waiting to give out a new schedule, since they have created several up to this point.
