Board Committee Reports

Finance/Personnel – Met tonight. The January report was handed out by Bing. We are in pretty good shape, but it is extremely hard to know what the numbers are in a normal year, since we have all the Esser funds. Discussed major influence with the State looking to increase the funding for our students for next year. Discussed the forestry contract – we are looking at an income of just under \$30,000 into the general fund. Biewar Lumber to start in May and be completed by June is the plan. Personnel did not have much to discuss. We had a couple of superintendent candidates tour the district this past week. The posting does close Friday, February 18. Michael asked regarding the timing of the state budget – Bing hopes that it will be completed before we adopt our budget. Jen asked regarding the financial status of the plowing/salting. Ryan advised that we are within budget and doing well. Matt asked regarding retirements – we have five confirmed commitments for retirement. Next meeting will be Thursday, February 24, at 6:00 p.m.

Facilities/Policy – Next meeting will be February 28 at 6:00 p.m. Ryan took the floor to explain the bids for the softball dugout reconstruction. There were three bids from \$89,000 to the wining bid of \$62,000. Approximately \$40,000 to \$45,000 will be covered by insurance because it would be rebuilt as is....we are adding composite benches and a metal roof which are upgrades. Ryan does reach out personally to the locals for bids. Matt would like the breakdown of costs. Wing hopes to get started by March, and it will be a two week project, so should be ready by the season.
