Dear Quest Families,

I hope this letter finds your families healthy and staying safe! I want to start by thanking you for your patience while we worked on creating a Continuity of Learning Plan for Quest. It was not a simple task. As most of you are aware, Quest is on a trimester schedule versus a semester schedule. With Quest being only 9 days into the third trimester, it was not feasible to finish classes like Fremont High School, which is on semesters and approximately halfway through their classes.

On April 3, 2020, the Fremont Board of Education made the decision to allow all credit recovery courses for remainder of the 2019-2020 school year, which ends June 5, 2020, be issued credit after completing 50% of the course (equivalent to the amount of time the other students have completed)

What this means to Quest students:

- It allows all Quest students the ability to continue credit recovery courses
- Quest students will be given the opportunity to complete up the six (6) Edgenuity courses until June 5, 2020 (equivalent to the 3 credits that they would earn if we were still on-site)
- Credit will be issued once 50% of the class is completed with a grade of 70% or better.
- Courses that are started but not finished by June 5, 2020 can be continued in the fall; however, 100% completion will be required.
- Students may begin working on Edgenuity at any time. Edgenuity is available 24 hours a day/7 days a week.
- Teacher Advisors will be facilitating the Edgenuity classes for their Advisory students.
- Teacher Advisors will have "office hours" at least two times per week for two hours each time.
- Teacher Advisors will check in weekly with each advisor student to provide additional support and resources.

Mr. Miller and I tried contacting every Quest Family this week to determine internet and electronic device access; however, we had to leave messages at some homes.

During the week of April 13 -17:

- Students will be receiving through the mail a packet with additional instructions, staff contact information and other helpful resources.
- Teacher advisors will be calling the students assigned to their advisory to check in and ask a few survey question to help us determine students' individual needs.

As additional support for our Quest students, Mrs. Wosinski will be available for Virtual "Resets". Please send her an email at dwosinski@fremont.net and she will set up a time to talk with you.

A personal message to the Quest students – Don't forget we are in this together! While we may not be able to be together in person, our Quest staff misses you and thinks about you every day. Take advantage of this credit recovery opportunity you are being provided. Please reach out if you have any needs or just need to talk. You are not alone and I (we) love to hear from you even if it is just a hello, I am doing well! Remember to Stay Safe and Stay Home so we can get through this quarantine quicker!
